### **Rules and Conditions**

- Church groups, businesses, and other organizations must provide a Certificate of Liability Insurance naming Pathfinder Lodge as additionally insured.
- Pathfinder Lodge is not responsible for lost, stolen, or damaged items.
- The swimming beach is only open when there is a lifeguard on duty. Pathfinder does not always have a lifeguard on staff, particularly after the youth camp season ends (third week of August).
- Patrons using canoes and kayaks must sign in and out at the Snack Shaque. Paddlers must also wear a lifejacket (provided). There shall be no more than 3 people in a canoe and no more than 1 person in a kayak. (Currently, no tandem kayaks are available.)
- If requesting kitchen supplies, please provide a list of items needed (tongs, bowls, serving spoons, etc). Items will be supplied in a container with an itemized checklist and must be returned to the camp host.
- Campfires must be properly extinguished before leaving the site. Buckets and water sources are available at each fire site.
- Quiet hours are observed from 10:00 PM 6:00 AM.
- Pets are allowed only upon request. Proof of rabies vaccination must accompany all pets.
- Please remember that this is a camp, not a hotel. While facilities are regularly cleaned, a certain amount of dirt is a normal part of camp, such as insects, leaves, pine needles, etc.
- Pathfinder Lodge is primarily a children's camping ministry affiliated with the American Baptist Church and maintains a family camp atmosphere.
- The following is prohibited on camp property: alcohol, drugs (including recreational marijuana), tobacco (includes cigarettes, cigars, pipes, and vape pens), firearms, foul language, fireworks, fighting, violence and threats of violence.
- VPCCM is not responsible for accidents, damage, or injury to our guests or for loss of money or valuables of any kind.
- Vick and Pathfinder Camp and Conference Ministries reserves the right to refuse any individual or group access to our grounds. Any individual or group denied access will receive a full refund of any monies paid, unless their refusal was the result of breaking our stated or written rules and guidelines
